It was moved and seconded to adopt the Distribution of Ruling Elder Commissioners Plan to ensure that, insofar as possible, equal numbers of ministers of the Word and Sacrament and ruling elders are present to vote in presbytery meetings. The plan is as follows:

YAV Commissioning

Rev. Larissa Kwong Abazia explained the order of the commissioning for Jordan Heinzel-Nelson's year of service as a Young Adult Volunteer in Dundee, Scotland. Pam Mellman, YAV Site Coordinator in Scotland, provided a video welcoming Jordan and explaining what the year would entail. Jordan spoke of her excitement to be part of this program. Core Transition Team

Rev. Hannah Lovaglio reported on the work of the Core Transition Team. Since the last presbytery meeting, the NJ Missional Communities AC has taken on the role of the presbytery council, which freed the Core Team to dream dreams. In this time of transition they have not run out of grace. Rev. Lovaglio reported that there is a communications plan. The website is up, but needs photos of our congregations at worship and work. The team has developed a media release form that can be used by any congregation. There will be a process for choosing a new name for the presbytery announced in the next weeks.

Rev. Chris Houtz, liaison to the Justice petal team, described a program that has been developed by John Fong: Be Like Water: Asian American Allies. This program is described as "Allies and Practices to face hate against the Asian American Community." The program is currently sponsored by the New York City Presbytery. A motion was made for the presbytery to be a New Jersey Sponsor for Be Like Water. This includes promotion and recommending potential allies and experts to provide content for the program. **Approved.**

Rev. Diane Ford assumed the role of moderator.

Rev. Ford thanked the Allentown Presbyterian Church for virtually hosting the presbytery meeting.
