### **POLICY REGARDING COVID PRECAUTIONS AT PRESBYTERY-RELATED EVENTS**

Recognizing that the need to take precautions can vary in different parts of the state and that individuals will have varying degrees of comfort regarding meeting in person, the following guidelines should be followed for all meetings or worship called for presbytery purposes. These guidelines are NOT intended to direct the meetings and worship of individual churches.

#### **Meetings of Full Presbytery**

Until further notice, all full presbytery meetings will be conducted via Zoom.

#### **Presbytery Committee or Small Group Meetings**

Committees and small groups may meet in person, but the following must be observed:

1. Meetings must take place in rooms with good ventilation and that are large enough to enable participants to observe safe social distancing.
2. Everyone in attendance will wear masks regardless of vaccination status.
3. A virtual meeting option must be made available for members who are not comfortable meeting in person.

#### **Worship Services**

All those attending and leading worship services related to presbytery business – for example, ordinations and installations – will follow the COVID safety precautions in place at the host church. If the technology is available, remote access to presbytery worship services should be offered.

Linda Gilmore shared the August 2021 financials for the former New Brunswick Presbytery, as there is not yet consolidated reporting.

It was moved and seconded to approve the purchase and acquisition of a manse by Tower Hill, the First Presbyterian Church at Red Bank. The down payment is \$355,530 and the encumbrance is \$829,570. **Approved.**

There was a discussion about the House of Hospitality in Trenton. The building is owned by Central NJ Presbytery and is used by a separate nonprofit organization that does not pay rent. The Presbytery insures the property and the nonprofit pays the taxes. The non-profit organization has a desire to dissolve and have the House of Hospitality become a mission of the presbytery. It was moved and seconded to do the due diligence and have the home inspected in the near future. If the nonprofit dissolves before the completion of the due diligence, the Trustees will move toward selling the property. **Approved.** The treasurer will communicate this decision to interested parties.

It was moved and seconded to approve the following resolution:

The Trustees of the Presbytery of Central New Jersey hereby resolve that the following persons are empowered to act on behalf of the Presbytery, individually, or where required, together, in regards to accounts with financial institutions including bank accounts and brokerage accounts, including but not limited to trading authority with New Covenant Funds and New Covenant Trust Company.
